Gentlemen:

We, citizens and taxpayers of San Diego, respectfully protest against, and ask you to deny, the applications by lumber companies for leases to the newly reclaimed harbor tidelands between Atlantic and 8th streets.

These lands, though only 88 acres in area, are practically all that remains of our industrial waterfront. They comprise that section of the harbor front which is unexcelled for piers, railroad yards, warehouses, productive industries and all the requisites to the upbuilding of the commerce of the port and the commercial activities of the city.

An asset of such value should not be exhausted under leases that will fail to secure for the entire city the greatest measure of wealth and prosperity.

We submit to your consideration that the proposed leases of these lands for lumber yards and allied uses:-

1st - Will deplete the industrial waterfront.

2nd - Will hamper and retard the commercial and industrial growth of the city.

3rd - Will subject the city to an unnecessary and serious fire hazard.

4th - Will be against public policy.

5th - Will result in the waste of these public lands.

6th - Will be contrary to the recommendations of the harbor engineers and inconsistent with the true intent of the Nolen plan.

We further ask that in a matter of so grave importance the pending applications, and the recommendations of the Harbor Commission, be first published in local papers for three weeks before being acted upon.
